# Greenhouse Shelter



Chicago's first domestic violence shelter, Greenhouse Shelter, has been a safe haven for survivors since its inception in 1979. Greenhouse Shelter provides a safe refuge and nurturing environment for adult survivors and their children.

Safety planning, court advocacy, individual counseling, group counseling, legal advocacy, art therapy, and family trauma therapy are among the core services available for all residents. Our shelter offers multilingual and culturally-specific services; over eight languages are spoken by Greenhouse staff.

Greenhouse is also the home of CAWC's 24-hour hotline, responding to over three thousand crisis calls per year.

# Hospital Crisis Intervention Project



Housed at John H. Stroger Hospital and Northwestern Memorial Hospital, CAWC's Hospital Crisis Intervention Project (HCIP) provides direct domestic violence services at the critical time in which survivors seek health care.

Domestic violence counseling, crisis intervention, and advocacy is available at bedside for hospital patients who are receiving medical treatment. Ongoing counseling is offered to all clients.

CAWC's hospital program also provides domestic violence education and training for medical providers, social workers, and other hospital personnel. These trainings are designed to help medical staff identify and respond to victims of domestic violence.

# Humboldt Park Outreach Program



The Humboldt Park Outreach Program (HPOP) offers a full range of bicultural and bilingual services to adult and child survivors of domestic violence. These services are offered on an appointment or walk-in basis. HPOP is a community-based counseling outreach program for those victims of domestic violence who either have left shelter and begun independent living or have not yet made the decision to leave their abuser.

Clients may choose to receive individual counseling services or to join one of our survivor support groups. HPOP also conducts a weekly children's support group. Services include crisis intervention, counseling, legal advocacy, safety planning, DCFS education groups, and enhanced children's services.

# DV Services at Haymarket



CAWC's DV services at Haymarket Center program provides domestic violence intervention and educational services to residents of Haymarket Center, one of the largest substance abuse treatment facilities in Illinois.

The Haymarket Program Services Coordinator conducts weekly education groups for Haymarket residents. These groups discuss domestic violence, patterns of abuse, connections between substance abuse and domestic violence, and healthy relationships.. Individual counseling, safety planning, crisis intervention, life skills training, and other core domestic violence services are also offered through our program at Haymarket Center.

# MDT Program



In January 2019, CAWC began a new partnership with the Chicago Police Department's 14th District. The program, Multi-Disciplinary Team (MDT) services at CAWC, is housed at Greenhouse Shelter. As a part of the MDT program, the Chicago Police Department's 14th District connects domestic violence victims to CAWC when they respond to 911 calls related to domestic violence. When the police meet with domestic violence victims, they give them the option to complete a Domestic Violence Assessment Form that details information about their abuse and to request follow-up services from CAWC.

CAWC staff contact each survivor to provide immediate crisis support via phone; these crisis services include safety planning and lethality assessments. Survivors are also given information and direct referrals to CAWC's counseling programs, shelter, legal advocacy program, and other services. Many clients move into other CAWC programs, including Greenhouse Shelter, the legal advocacy program, or the HPOP counseling program.

This partnership allows CAWC to reach additional clients and since the services are offered at the time of the emergency response, we're available to provide a quick response to victims at the time of crisis.

# Emergency Hotel Program



In March 2020, CAWC’s Greenhouse Shelter had to significantly reduce on-site capacity in response to COVID-19—dropping from 42 to 25 beds. In order to support as many survivors as possible, CAWC created an Emergency Hotel Shelter Program. Through this program, survivors were housed in safe hotel suites, while still having full access to all of CAWC’s core domestic violence services. Survivors received crisis intervention, counseling, housing advocacy, legal advocacy, food vouchers, and family trauma therapy.

The program rolled out in March 2020 and provided nearly 500 nights of shelter by the end of June 2020. Most Emergency Shelter Hotel Clients moved into Greenhouse Shelter or permanent housing at the end of the their hotel stay.

# Irene's Story



In March 2020, due to COVID-19, Irene was suddenly isolated with her abuser. Irene's office closed and all employees were asked to work from home. She felt trapped. Irene's abuser locked her in the apartment and did not allow her to leave. Irene's husband also physically and verbally abused her.

Irene contacted CAWC through our 24-hour hotline when her abuser was asleep. While talking with a counselor on the phone, she made a plan to leave. Irene quietly gathered some personal belongings and she took a cab to CAWC's Greenhouse Shelter in the middle of the night. Irene disclosed to her counselor that this was the second time she left her home due to abuse. She was afraid to reach out to her family. Irene's counselor explained that many survivors leave several times before leaving for good.

Irene was enrolled in CAWC's Emergency Shelter Hotel Program. While quarantined in the hotel, Irene received daily phone and video counseling. Her first goal was that she wanted to feel at peace. She took things one day at a time, and if that was too much, her counselor encouraged her to take things one minute at a time.

Through the assistance of CAWC, Irene found a new apartment and is continuously working towards a life filled with peace. Most importantly, Irene found support during these hard times. She knows that she is not alone and that she has people fighting with her, and fighting for her.



**U.S. Women have experienced severe physical violence by an intimate partner at some point in their lifetime**



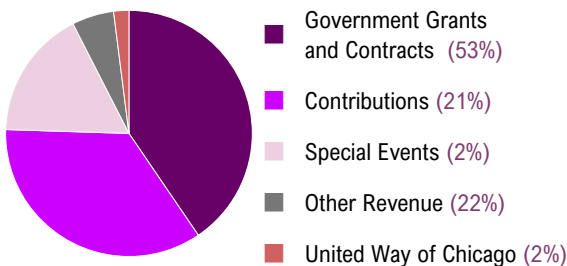
**U.S. Men have experienced severe physical violence by an intimate partner at some point in their lifetime**

# Financial Report

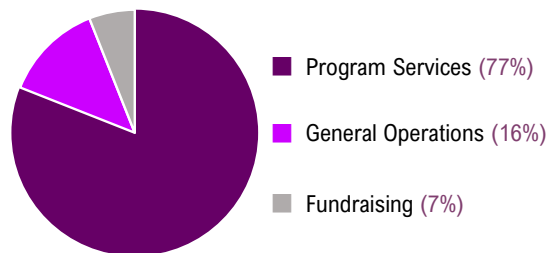
CAWC is a financially stable nonprofit organization, thanks to the generosity of our donors, a diversified funding base, and diligent efforts to keep overhead costs low. CAWC maintains a six-month cash reserve. Our \$1 million endowment provides additional income and liquidity. In FY2020, 77% of CAWC's expenses were for programs to serve survivors of domestic violence.

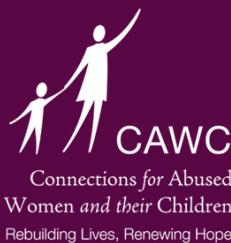
